

Hi,

**from Monday, November 22, 2021**, a new government regulation related to covid-19 comes in force. Unfortunately, for dance studios, this means that **with a few exceptions (see below), we can no longer accept "covid passes" in the form of tests**. In general, either prove of vaccination (at least 14 days after the second vaccination) or prove of suffered covid (in the last 180 days) will be necessary to enter the dance studio.

**WHAT IS VALID FOR WHO:**

**Children under 12 years old:** do not have to prove anything, have free access to the dance studio,

**Children and teenagers 12-18 years old:** prove vaccination, suffered covid, or negative PCR test not older than 72 hours (Ag tests will no longer be valid) - 5 PCR tests per month are going to be free at sample points (paid by health insurance companies),

**Partially vaccinated adults over 18 years old:** prove suffered covid, or started vaccination + negative PCR test not older than 72 hours (Ag tests will no longer be valid) - 5 PCR tests per month are going to be free at sample points (paid by health insurance companies),

**Unvaccinated adults over 18 years old:** prove suffered covid (no tests will be valid),

**Fully vaccinated clients (min. 14 days after the second vaccination):** prove vaccination.

It is clear to me that some of you guys - our clients - do not meet the above-mentioned conditions for entering the dance studio and it would not be fair not to give you a chance to adequately compensate for the classes you paid for. On the other hand, please understand our situation - wages of our dance teachers are calculated from the total course fees collected and each of our teachers expects such a wage within the given season; therefore, it is not possible to return the course fee to you directly.

**SOLUTION TO THE SITUATION OF UNVACCINATED ADULTS:**

**If you are over 18 years old, have not been vaccinated at all, have not suffered covid-19 in the last 180 days and you are not entitled to free PCR tests, please email me by 30.11.2021 that you can no longer attend the ongoing dance classes for these reasons.** Subsequently, I will unsubscribe you from the ongoing dance course and keep the entire course fee of unused classes in our system in the form of credit, which you will be able to apply during the SPRING 2022 season for any classes that will not be fully occupied during the SPRING 2022 season. In other words, about half of your course fee will be transferred to SPRING 2022 and as soon as the government regulation releases and you are able to attend dance classes again, you will use the credit for any of our classes that will not be fully booked. You will be able to "pay" for single classes using the credit, or you will apply the entire credit as a discount on the spring course fee (i.e. you will only pay the price difference).

In case of weekend workshops, we will proceed similarly - you will be able to use your prepaid money during spring either within regular classes or within workshops.

**Please note that if you do not email me by November 30, 2021 that you do not meet the conditions for entering the dance studio from November 22, we will suppose that you can attend the classes and you will lose the chance to transfer the course fee to SPRING 2022. In other words, we will not transfer your course fee to the spring season automatically just based on the fact that you do not attend the classes!**
